



URP VALUE 2021 AND JUDICIAL FEES VALUES CHART

Introduction

At the beginning of the fiscal year 2021, the new Procedural Reference Unit (URP for its acronym in Spanish) has been approved, as well as the new Judicial Fees Values Chart, which will be in effect during the mentioned annual period.

The aforementioned was executed through the Administrative Resolution N° 000393-2020-CE-PJ, published on January 6, 2021, establishing that **the value of the URP will be PEN 440.00**; that is, an additional amount of PEN 10.00 in relation to the value of the URP that was in effect during the year 2020, which amounted to PEN 430.00.

The referred modification in the value of the URP is based on the increase in the value of the Tax Unit (UIT for its acronym in Spanish), which for the year 2021 has been fixed at the amount of PEN 4,400.00. The above considering that the value of the URP is equivalent to 10% of the UIT.

Additionally, as indicated, the regulations under comment have approved the new Judicial Fees Values Chart, corresponding to the judicial fees that will be applicable before the execution of different acts during the development of a judicial process.

Considering the above, we share below an extract of the Judicial Fees Values Chart applicable for the year 2021, indicating the main procedural acts that may occur in a Contentious or Non-Contentious Process, mentioning the corresponding value of their judicial fees.
